**RETREAT CANCELLATIONS**

It is your responsibility to read and understand our terms and conditions and cancellation policy before making a reservation. Upon booking your Blue Lotus Infused Wellness Retreat you are agreeing to these terms and conditions and the RELEASE OF LIABILITY AND ASSUMPTION OF ALL RISKS (on page 2).

**DEFINITIONS**

“Cancellation” is defined as not attending your scheduled retreat, including postponing or rescheduling. Cancellation includes being unable to attend the retreat due to travel restrictions or an act of god.

“You” refers to the guest booking a Blue Lotus Infused Wellness Retreat.

“We” refers to Scarlet Strapko for MediaFocus International, LLC.

“Retreat” refers to Blue Lotus Infused Wellness Retreat.

**TERMS AND CONDITIONS AND CANCELLATION POLICY RETREAT REQUIREMENTS**

You must be 18+ years of age and female to attend a Blue Lotus Infused Wellness Retreat.

**GUEST CANCELLATION POLICY**

Please read the specifics of our cancellation policy. We offer a grace period where you can have a full refund without questions when cancelled more than 21 days of retreat date. Refunds may take a maximum of 30 days to process. If you cancel less than 21 days before your retreat starts, 100% of your payment may be applied as credit to another Blue Lotus Infused Wellness Immersion retreat within one year of the retreat date. Retreat prices may differ, so if you apply your payment as credit towards another retreat, you will settle the balance to meet the retreat cost of the retreat you are attending. Exceptions to our policy cannot be made for any reason. We do not offer credit or refunds for a guest arriving late or leaving early for any reason. You understand upon booking that the retreat host may change due to sickness or other personal issues. In the unlikely event this was to happen, no refunds or returns are possible.

**RETREAT CANCELLATION POLICY**

We never want to cancel a retreat. However, sometimes acts of God do happen. If we need to cancel a retreat for any reason, your full retreat payment will be credited towards the next possible retreat date.

**TRAVEL CANCELLATION INSURANCE**

We suggest you obtain travel insurance if you are attending the retreat from out of town. Depending on the policy and conditions, travel cancellation insurance will pay for some or all cancellation fees. With most agencies, insurance must be purchased within 14 days of making your reservation.
